I was born in 1970 in Baku city in the doctor's family.

In 1987 I finished Russian sector of Baku city secondary school No.9, in 1987-1989 years I passed serving in Soviet Army in Middle Asia in motored—shooting forces, in region boarded with Afghanistan and Iran. I had to take part in hostilities against armed formations for protect the civilian people. After the Service I returned to my home city and started working in the state enterprises and offices, including the Armed Fire Service of Azerbaijan Republic.

In 1995 I left at Astrakhan region, Russian Federation to work on the fishing

flotilla's ships. After 1 month of working there I was appointed as Team leader and 1-st Class Helmsman. In 1999 I returned to my home and was employed

for the "Caspian State Shipping Company" (ASCO). My working regions was: Caspian Sea, Black Sea, Mediterranean Sea, Atlantic Ocean (Bay of Biscay), all kinds of vessels with maneuvering operations in Bosphorus, Volgo-Don Canal, Gibraltar etc. I had worked there up to 2006. From 2006 to 2008 I was

employed for "SIR-Group" and "Altes-Group" security companies, assigned to "safety leader" position. I have good knowledge and experience with working of hotels, hostels and so on. From 06.05.2008 up to 05.12.2008 - my assignment was in Emergency Situations Ministry of the Republic of Azerbaijan as a

Navigation Officer - Rescue Team Leader, where I was demobilized with contract termination. I can read the Buildings Plan, Fire Plans etc.

In 2010-2011 I was admitted to "Palmali Shipping" company (Malta). From October 2011 to July 2012 (contract was terminated) – Skipper/ Captain-in-Charge in Port of Baku, Azerbaijan Republic.

In 2012 to 2013 I took part in several contracts for some private vessels as navigation officer, which transported humanitarian goods at Libya and Egypt. All kinds of my work done within compliance of ISPS, SOLAS, MARPOL and other International Conventions.

From September of 2013 to January of 2015 – Chief of Laboratory of Navigation of Azerbaijan State Marine Academy, where I was designate with order of ASMA Chancellor, Prof. Bashirov personally. My responsibilities was a looking for sufficiently condition of the training navigation environment, preparation of training projects and working with students.

Interesting fact from my biography:

From 04/2016 to 12/2016- I was Captain-skipper to the one of the head important projects for Azerbaijan - "BP Exploration" and "FESCO Geokinetics" companies consortium as SWAP (Shallow Waters Absheron Peninsula), Captain on "TZ-3226" VSGA (Very Shallow Gun Array) vessel. Our responsibilities and work environment was:

Using of seabed seismic acquisition method using a number of source vessels as determined by water depth from 2 meters till 100-150 meters above.

At shallow water zone: Two aluminum hulled catamaran vessels each equipped with a compressed air operated energy source array operating 24 hours a day. Pressure level: 5 Bar.

Reason of leaving — Termination of contract.

From 08/2017 to nowadays – Training Master of the "SOCAR"'s Teaching Training and Certification Departament, where we train members of oil companies with ISM Code for self surviving techniques, BOSIET, HUET, FOET, including also "HAZMAT", "IMDG", tankers familiarisation, industrial divers preparation and so on trainings.

In addition to scientific activities, in parallel with this, I also have experience in the maritime industry, as indicated above in my application form, which includes service both on merchant ships and on offshore support vessels.

- 2) Azerbaijan State Marine Academy—Navigation and Ship Management faculty, Bachelor degree, Rank—Officer of Navigation for vessels over 500 tons gross tonnage without limitation of sailing.
