(3) Should you lose this book other than by shipwreck, you will not obtain a new one until your next discharge and a fee will be chargeable; but you may obtain at once, by applying to the Registrar of Ships, Zanzibar, and forwarding the office fee, extract from the Agreements and Official Logbooks of the vessels in which you have served, showing service and character.

(4) Any Person who-

- Makes a false report of character under this Act knowing the same to be false;
- forges or fraudulently alters any certificate of discharge or report of character;
- fraudulently uses any certificate of discharge or report of character; or copy of a report of character which is forged or altered, or does not belong to him;
- assists in committing or procures to be committed any such offences as aforesaid;

shall be guilty of an offence under the act.
