- Included contracts on five different oil and gas tankers between 170m and 250m in length, each with between 20 and 25 crew members.
- As an OOW, I routinely stood watch on the bridge during the day and night, sometimes while transiting busy waterways such as the Strait of Dover, Taiwan Strait, and Singapore Strait.
- When leading mooring and anchoring operations, I ensured that my team were well briefed and wearing the correct PPE. I was also in charge of communications with the bridge.
- As the designated safety officer, I was responsible for the upkeep of all LSA and FFE, recording of safety drills and training, and recording of safety meeting minutes. In addition, I was a member of both the fire fighting and rescue boat teams.
- Monitoring cargo operations was a regular part of my work, which involved checking the stability of the vessel and adding or removing ballast as necessary. On two occasions, I had to react quickly and decisively to ensure the safety of the vessel when some of our lines parted.

- When sailing in areas with a risk of piracy, we would carry security personnel. During my watch
 while transiting the Bab-el Mandeb Strait, we were once surrounded by five speed boats at a
 range of approximately 1nm. I alerted the security team who took up strategic positions.
 Fortunately, their presence was enough to deter the boats.
- We routinely sailed in heavy weather. On one occasion, after tracking the path of a strong storm while transiting the Singapore Strait, I informed the Master that we would be coming within 250nm of the storm. The decision was taken to stop the vessel until it passed.

- Included contracts on two different oil tankers, both of which were 183m in length and carried approximately 20 crew members.
- Kept a bridge watch with the chief officer, and reported to them while on board.
- Worked with the bosun to maintain the ship in good order. Chipping rust and painting were tasks that I routinely completed alongside the rest of the deck team.
- During cargo operations in port, I would be directed to close and open valves, drain cargo lines, connect and disconnect hoses, and stand watch at the gangway.
- Secured the ship for sea before every departure, which included a stowaway search. We would also regularly perform stowaway and security drills.
- After completing my sea phases with Wilhelmsen Ship Management, I returned ashore to complete my OOW training and exams. After receiving my CoC I was offered the position of 3rd officer.
