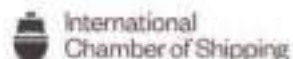

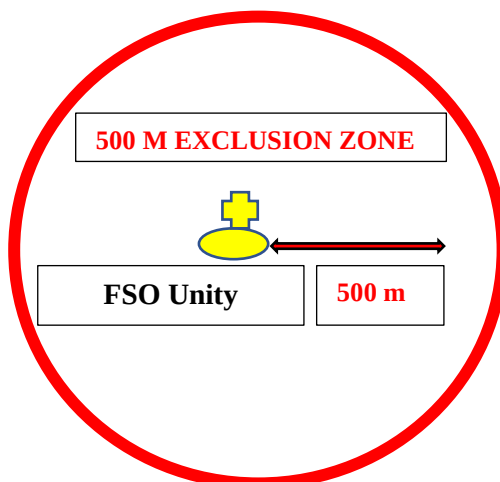

1) FSO Unity Restriction Area 500 m:

- Diving operation will take place at FSO Unity on mooring chains
- Diving support Vessel “Enigheno Florence” will show A flag during diving activities.
- Working VHF Chanel 77 and Back-up VHF 72
- Vessels will be allowed to enter the 500 m zone only if FSO MOM or his delegate (OLC) grant them the access after confirming with the diving Supervisor of the location of diving.
- At no time should any vessel approach same side of the diving operation without receiving clearance

2) AM Pleasure Restriction Area 200 m:

- AM Pleasure Restriction Area during diving operation will be 200 meters
- Diving support Vessel “AM Pleasure” will show “A” flag during diving activities
- Working VHF Chanel 77 and Back-up VHF 72
- Vessels will be allowed to enter the 500 m zone only if FSO MOM and / Or Diving Supervisor durin
- diving operation grant them the access

All vessels approaching or departing ODUDU oil field must keep a safe distance from FSO Unity, CALM Buoy or AM Pleasure of at least 500 m when the operation is in progress.

All surfers/FCB/ Security vessels and Supply vessels are not authorized to cross the restriction areas mentioned above at any time.

:
