PERSONAL SKILLS

I have extensive experience in ship handling, mainly with coastal vessels in North-western European Ports, undertaking own pilotage.

During my employment as Simulator Manager / Instructor, have acquired an extensive experience in developing and delivering a range of pilotage and ship handling training sessions and exercises. I was the lead instructor on our general Ship Handling Course.

I am an MCA approved assessor and trainer for existing OOW candidates moving to Chief Officer/Master. I am an approved MCA assessor for the NAEST (O) and (M) courses.

I have had full managerial responsibility for the operation of the simulator. This required preparation and delivery of the pilotage training which the centre undertook for numerous pilotage services, particularly Southampton, Dover, Aden and Saudi Arabia. This experience has not only expanded my knowledge of ship handling but has allowed me to develop successful strategies of handling a wide variety of vessels in varying sea conditions. These vessels range from conventional small to medium size product tankers / cargo ships to a very large Tanker / Container vessel.

I have developed a vast experience in vessels with varying Rudder and Propulsion systems including CPP, Fixed pitch, High lift rudders as well as conventional semi balanced rudders. I also had an opportunity to learn and work different tug types, i.e., ASD and Voithschneider propulsion systems. This included developing training sessions for tug crews to undertake Escort Towage work, which was then incorporated into the Ports Marine Safety Code.

Working with several clients has allowed development of ship handling skills in emergency situations. i.e., Loss of engine / steering and thrusters. Work with a ferry client has allowed development of handling of vessels with tugs, both dead ship and with loss of one engine to satisfy PEC requirements for one of their operational ports.

Have also gained extensive experience working within the constraints of the Port of Liverpool in regard to significant tidal range and entry into the enclosed dock system.
