



- 1. This document is issued under the provisions of Section, 117 of the Merchant Shipping Act, No. 21 of 2003. It should be handed to the Registrar of Seafarers or Consular Officer when signing Articles of Agreement, so that the engagement column may be filled in.
- 2. Should you desert or fail to join, your document will be deposited with the Registrar of Seafarers or Consular Officer at the port where you left the ship, who will retain it for two weeks from the date of the vessel's leaving, at the end of which time it will be forwarded to Dar es Salaam. Upon you applying for your document, it may be returned to you containing an entry in the discharge and character columns that the voyage was not completed; but if you have wilfully, or through misconduct; failed to join your ship, the Registrar of Seafarers may withhold the document for such period as he thinks fit and may refuse to furnish copies of your certificates of discharge.
- 3. Should you lose this document other than by shipwreck you will not procure a new one until your next discharge and a fee will be chargeable; but you may procure at once, by applying to the Registrar of Seafarers, Dar es Salaam, and forwarding the office fee, an extract from the Agreements and Official Log Books of the vessels in which you have served, showing service and character,
- 4. Under Section 154 of the Act, Any person who-
- (a) makes a false report of character under this Act knowing the same to be false;
- (b) forges or fraudulently alters any certificate of discharge or report of character:
- (c) fraudulently uses any certificate of discharge or report of character, or copy of a report of character which is forged or altered, or does not belong to him;
- (d) assists in committing or procures to be committed any such offences as aforesaid;

Shall be guilty of an offence under this Act.
